

# Privacy Policy

Freeit Data Solutions, LLC and its subcontractors (“Freeit” or “we” or “our” or “us”) is committed to the protection of the privacy of our customers and website visitors. We have established this Privacy Policy as a means of disclosing to you how we collect, utilize, distribute and protect your personal information. For the purposes of this Privacy Policy, “customer” shall mean any past, current or prospective customer of Freeit, including any visitor to the Freeit website. This Privacy Policy governs the manner in which Freeit collects, uses, maintains and discloses information collected from its customers. By visiting our website or otherwise providing Freeit with your personal information by any means, you accept and consent to the practices described in this Privacy Policy.

This Privacy Policy covers our collection, use, and disclosure of information we collect through our website located at <http://www.freeitdata.com>, our customer portal located at <https://portal.cirrity.com> and/or <https://mygreencloud.com>, and our Cloud Services. The use of information collected through our service shall be limited to the purpose of providing the service for which the Client has engaged Freeit.

## Information We Collect

Freeit may collect personally identifiable information from customers in a variety of ways, including online and offline subscription and order forms, paper or telephone submissions, and other instances where customers are invited to volunteer such information. Additionally, contact information may be collected during any correspondence relating to support, as well as in connection with Freeit services. Freeit may collect such information as contact name, business name and type, address, phone number, email address, as well as other information.

## Log Files

As is true of most web sites, we gather certain information automatically and store it in log files. This information may include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and/or clickstream data.

We do not link this automatically-collected data to other information we collect about you.

## Tracking Technologies

Freeit and its partners use cookies or similar technologies to analyze trends, administer the website, track users’ movements around the website, and to gather demographic information about our user base as a whole. You can control the use of cookies at the individual browser level, but if you choose to disable cookies, it may limit your use of certain features or functions on our website or service.

We partner with a third party to display advertising on our website or to manage our advertising on other sites. Our third party partner may use cookies or similar technologies in order to provide you advertising based upon your browsing activities and interests. ## Data Integrity and Security

The security of your personal information is important to us. We follow generally accepted standards to protect the personal information submitted to us, both during transmission and once we receive it. No

#### Data Access

Upon request Freeit will provide you with information about whether we hold any of your personal information. Customers may access all personal identifiable information that we collect and maintain by contacting us by mail or telephone at the contact information listed below. They can correct, update and delete factual errors in personally identifiable information by contacting us by mail or telephone at the contact information listed below. To protect customer privacy and security, Freeit reserves the right to take reasonable steps to verify customer identity prior to granting access or processing changes or corrections. Any requests for access to personal information will be answered within thirty (30) days.

We will retain your information for as long as your account is active or as needed to provide you services. Please contact us if you wish to cancel your account or request that we no longer use your information to provide you services. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

Freeit acknowledges that you have the right to access your personal information.

Freeit has no direct relationship with the individuals whose personal data it processes. An individual who seeks access, or who seeks to correct, amend, or delete inaccurate data should direct his query to the Freeit's Client (the data controller). If requested to remove data we will respond within a reasonable timeframe.

We will retain personal data we process on behalf of our Clients for as long as needed to provide services to our Client. Freeit will retain this personal information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements. Freeit may transfer personal information to companies that help us provide our service. Transfers to subsequent third parties are covered by the provisions in this Policy regarding notice and choice and the service agreements with our Clients.

#### How Information is Used

Freeit may contact customers regarding products and services offered by Freeit and its trusted affiliates, business partners, and independent contractors. We will share your personal information with third parties only in the ways that are described in this Privacy Policy. We do not sell your personal information to third parties. We may also use information collected through the Freeit website for research regarding the effectiveness of the Freeit website and related marketing, advertising and sales efforts. Information will only be made publicly available where mandated by governing agencies, in response to subpoenas or court orders, or as disclosed in the terms and conditions of our agreements with customers.

#### Electronic Mail

Electronic communications may be sent by Freeit using customers' personal contact information to inform them of new products, important industry news or general services and upgrades provided by Freeit. If customers do not wish to receive these industry notices, they may at any time opt-out of our marketing by clicking the Unsubscribe link located at the bottom of all marketing and customer notices.

However, in order to meet our service agreements, Freeit will continue to send emails regarding customers' account administration or maintenance notifications.

#### Disclosure

Information collected from customers may be disclosed to independent contractors and business partners who have agreed to hold this information in confidence, not use it for any purpose except to carry out the service they are providing for Freeit, and honor our privacy and security policies in the way this information is handled. This would include the third-party agent acting as a payment processor on our behalf, as well as the third-party agent hosting our chat feature. Freeit may also disclose aggregate, anonymous data based on information collected from customers to actual or prospective investors and partners. Should a sale of Freeit's business ever occur, collected customer information may be transferred along with the sale but the information will be treated in the same manner as set forth in this Privacy Policy. We may also disclose your personal information as required by law, such as to comply with a subpoena or other legal process, when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.

#### Children's Privacy
